Trailer On Flat Car (TOFC) Applications

Hendrickson Trailer Commercial Vehicle Systems has conducted a review of its trailer suspension recommendations for Trailer On Flat Car (TOFC) applications. As a result of on-site field evaluations and product testing, we have determined that the following component combination will provide the most optimized TOFC suspension performance:

- **Top-Mount Style Suspensions**
(i.e. INTRAAX[®] AANT or AAT models; VANTRAAX[®] HKANT or HKAT models)
- **SURELOK[®] Ride Height Lock Assembly without a SURELOK[®] Bypass Valve**

The use of Hendrickson's SURELOK Ride Height Lock Assembly is now recommended in order to best protect the suspension components.

Contrary to previous recommendations, a SURELOK bypass valve is no longer required when SURELOK is installed. We also no longer require the use of a suspension dump (or exhaust) valve for TOFC applications. As in the past, Hendrickson does not require the use of shock straps for TOFC applications equipped with SURELOK.



The above recommendations supersede Hendrickson's previous publications and should be used for any new TOFC trailer suspension installations. Hendrickson will continue to support all previous TOFC installations that were installed in compliance with our prior recommendations.
